BV (Business Value):

The profit from direct selling of products is determined as BV. And BV depends differently on all products.

Discount Price, valid for ID/Vendor holders only.





INSTRUCTIONS



ID/Vendor code apply

Free of cost & this may only require a refferal/sponsor. Only one ID will be generated per PAN Card number ID activation it should be 1000BV products purchasing and Vendor code activation it should be 2500BV products order.



Products return/replce policy

Products can only be repliced as per the products replacement Terms and Conditions. Becouse daily/weekly business closing is determined as per the business plan.



Pyramid scheme

The company is entirely dedicated to direct selling of products. And is a completely generation based refferal business plan.



Money transactions

Valid only through Company authorised Bank A/C & Authorised Vendor for products purchase/repurchase/order billing.



Business closing & Payouts

Business closing every night at 12 o'clock and payout next working day or Click to Pay systematically. Some closing will also be weekly/monthly.



Payout terms:

1.Must be at least INR 250/- TDS_5% will be applied on it, and Admin charges 2.5% will also be applied. Payout will be transferred only to the approved Bank A/C detail of the ID/Vendor holders.



KIND OF BUSINESS PROFITS:



Sell Profit amount is calculated on the basis of fixed percentage on Business Volume (BV) purchased/repurchased by Distributer/Associate and its group, details of which are given below:-



RETAILING

(i) Discount profit: up to 45%

(MPR discounts can vary from all products.)

(ii) Pocket Shoppe profit: 14%

(Order of 2500BV is mandatory to active Pocket Shoppe & 14% of the amount of BV at the time of order is less in DP rate billing. That's call Pocket Shoppe profit.

Example:

If your order DP value INR5000 and BV generated 2500BV then your profit will be 2500BV x 14% = 350/- now it will be less by DP order value such as DP5000 - 350 = 4650 have to pay for billing





- CTO ROYALTY BONUS, Which can also be called retirement bonus. This bonus starts getting from the RLB-DIAMOND rank that is made up to RLB-CROWN rank.
- CTO ROYALTY BONUS is divided into two slabs ranging from Diamond to Crown rank.

CTO ROYALTY BONUS will be equally divided between rank Achievers such as Diamond to Crown, depending on the RANK that has been fixed.

• DIAMOND & CROWN achiever's unconditional CTO Royalty will be given to your nominee.







- 1. At least four meetings or training company must comply with the responsibility in a month.
